

2007-08 Important Concepts Review

1. Before A1's free throw try hits the ring, B2, in a marked lane space, enters the free throw lane. A1's try is unsuccessful. Official awards A1 a substitute free throw. Is the official correct?
2. The coach of Team A is assessed a technical foul. Official advises the score the foul does not count toward the team total. Is the official correct?
3. While A1 is in the act of shooting, B2 pushes A2. A1's try is successful. Official disallows the goal and penalizes the foul committed by B2. Is the official correct?
4. A3 commits her fifth personal foul. After the official advises the head coach, the coach requests a timeout. The official grants the request. Is the official correct?
5. At the pregame meeting with the timer, the official advises the warning horn for a thirty second timeout should be sounded at 20 seconds. Is the official correct?
6. During a throw-in, A2 jumps from her frontcourt, catches the ball and lands in the backcourt. Official rules this a legal play. Is the official correct?
7. A1 while dribbling, touches B2 who is standing on the boundary line. Official rules A1 is out of bounds. Is the official correct?
8. Team A requests and is granted a full timeout. After 35 seconds, Team A is ready to play. Official directs the timer to sound the warning horn to shorten the timeout. Team B is not ready to play. Is the official correct?
9. Team A is awarded the ball for a throw-in. Official bounces the ball to A1. Before A1 catches the ball A2 contacts B2. Official rules this is a common foul. Is the official correct?
10. A2 sets a screen near the sideline. In going around the screen, A3 steps out of bounds. Official calls a violation. Is the official correct?
11. While A1 is dribbling in the frontcourt, A2 commits a blocking foul. Official rules this is a team control foul and awards the ball to Team B for a throw-in. Is the official correct?
12. During rebounding action, B1 is injured. After being beckoned onto the court, the head coach determines B1 is able to continue to play and requests that B1 remain in the game. Official advises the coach a timeout will be charged if B1 remains in the game. Is the official correct?
13. A1 has established her left foot as her pivot foot. Prior to releasing the ball on a pass to A2, she lifts her pivot foot. Official rules traveling. Is the official correct?
14. While closely guarded in the frontcourt, A1 holds the ball for four seconds, then dribbles the ball for four seconds. Officials calls a closely guarded five second violation. Is the official correct?
15. After releasing the ball on a throw-in pass, A1 delays her return to the court. Official rules a technical foul. Is the official correct?
16. After the horn indicating the end of a 30-second timeout has sounded, Team A is not ready to play. Official places the ball on the floor at the throw-in spot and starts the five second count. Is the official correct?
17. During A1's try for goal, the ball is in the cylinder above the basket when it is touched by A2. Official rules goaltending. Is the official correct?
18. A1 is airborne from the frontcourt when she catches a pass. Seeing she will land out of bounds, she requests a timeout to avoid the violation. Official grants the request. Is the official correct?
19. B1 is wearing a compression sleeve. The sleeve is not required for medical reasons. Official rules the sleeve is not dangerous equipment and allows B1 to wear the sleeve. Is the official correct?
20. Team A is awarded the ball for an alternating possession throw-in. During the throw-in, A2 commits a common foul. Team B is not in the bonus. Official awards the ball to Team B and instructs the scorer to change the Alternating Possession Arrow. Is the official correct?

21. As the official calls a traveling violation she notices the clock reads 34.5 seconds. The timer stops the clock at 33.6 seconds. Official rules the timer stopped the clock within the allowed one second and does not have the clock reset to 34.5 seconds. Is the official correct?
22. As A1 has the ball for a throw-in, B1 reaches through the boundary plane and contacts A1. Official rules this is an intentional personal foul. Is the official correct?
23. As A1 is dribbling, she bounces the ball off her foot and cannot immediately continue the dribble. In an attempt to retrieve the ball, A1 fouls B1. Official rules this a player control foul. Is the official correct?
24. A1's throw-in pass is batted by B1 and touches A1 who is still out of bounds. Official rules B1 caused the ball to go out of bounds and awards the ball to Team A for a throw-in. Is the official correct?
25. While A1 is dribbling in her frontcourt, A2 pushes B2. Team B is in the bonus. Official awards B2 a one and one. Is the official correct?
26. During a timeout, B6 reports to the scorer after the warning horn but before the horn to end the timeout. Official allows B6 to enter the game. Is the official correct?
27. A5 commits his 5th personal foul. After the head coach is notified, the official directs the timer to start the 20-second period and to sound a warning horn after 10 seconds. Is the official correct?
28. During a free throw before the ball hits the ring, B2 enters the lane followed by A2. Official rules a double violation. Is the official correct?
29. A1 jumps to shoot. Upon seeing his try will be blocked by B1, A1 releases the ball and starts a dribble. Official rules this is a legal play. Is the official correct?
30. Prior to the game, A1 dunks the ball. The official instructs the scorer to set the AP arrow when the ball is handed to the free throw shooter before the last free throw. Is the official correct?
31. B1 intentionally fouls A2 during A1's try for goal. The try is successful. Official awards A2 two free throws and then a throw-in at the spot closest to the foul. Is the official correct?
32. Team A is awarded an alternating possession throw-in. A1's throw-in pass is kicked by B2. Official rules the throw-in ended when it touched B2, awards the ball to Team A and instructs the scorer to set the arrow to Team B. Is the official correct?
33. While A1's try is in flight, A2 fouls B2. Official rules this is a team control foul and awards the ball to Team B for a throw-in. Is the official correct?
34. During the jump ball to start the game, the ball is legally tapped by A1. After touching A2, A1 while still in the center jump circle catches the ball. Official rules this is a violation. Is the official correct?
35. During a throw-in, A1 holds the ball through the boundary plane. B1 slaps the ball out of A1's hands. Official rules a technical foul. Is the official correct?
36. After releasing the ball on a try, airborne shooter A1 contacts B1 prior to returning to the floor. Official rules a player control foul. Is the official correct?
37. While holding the ball, A1 lifts her pivot foot before releasing the ball to start her dribble. Official rules traveling. Is the official correct?
38. A1 passes the ball from the backcourt to A2 who is straddling the division line. A2 lifts his foot from the backcourt and places it down again. Official rules this is a legal play. Is the official correct?
39. A2 catches the ball with one knee on the floor. Without moving either foot, A1 stands up and then starts her dribble. Official rules this a legal play is the official correct?
40. While A1 is in the act of shooting, A2 fouls B2. Official allows A1 to continue the try. Is the official correct?

41. B2 fouls A2. Team B is not in the bonus. Officials award A2 a one and one. After the first free throw is successful, the scorer advises the officials Team B is not in the bonus. Officials disallow the free throw and awards the ball to Team B for a throw-in. Is the official correct?
42. A1 is dribbling. During the dribble, the ball touches B1's leg and bounces away. A1 recovers the ball and dribbles again. Official rules this is an illegal dribble. Is the official correct?
43. A1 is assessed a technical foul during the pregame warmup. B6 reports to the scorer to replace B1 to shoot the free throws. Official disallows the substitution. Is the official correct?
44. A1 and A2 are assessed technical fouls for dunking prior to the game. In the second quarter the head coach of Team A is assessed a technical foul for unsporting conduct. Official disqualifies the coach and banishes him from the gym. Is the official correct?
45. A1 is dribbling the ball in her backcourt and passes the ball to A2 who is straddling the division line. A2 lifts her foot that is in the frontcourt and returns it to the floor. Official rules a violation. Is the official correct?
46. While the ball is at the disposal of thrower-in A1, B2 fouls A2. Official rules this is a personal foul. Is the official correct?
47. During an interrupted dribble, A1 fouls B1. Official rules this is a team control foul and awards the ball to Team B for a throw-in. Is the official correct?
48. While the ball is being passed between teammates, the head coach requests a timeout. Official does not grant the request. Is the official correct?
49. While the ball is being bounced to A1 for a throw-in, B1 contacts and displaces A2. Official rules a personal foul. Is the official correct?
50. During an alternating possession throw-in, A1 violates the throw-in spot. Official awards the ball to Team B for a throw-in and instructs the scorer to switch the arrow to Team B. Is the official correct?
